FINAL EXAMS

Glenbard District 87 Final Exam Schedule

Final exams will be administered during the week of May 18th for freshmen, sophomores, and juniors. During the week of final exams, students should continue entering their attendance during their second-period class.

Taking final exams during e-learning will (1) serve as a culminating closing experience for the course, (2) provide an opportunity for students to demonstrate understanding in the course material and improve their grade, and (3) potentially inform curriculum adjustments in the 2020-21 school year.

Taking a final exam cannot negatively impact a student's grade, only improve it.

Teachers will choose either to administer a final exam during a set period of time (see schedule below) or ask students to complete a project or assessment that occurs during finals week and submitted on the day their final is scheduled.

If a student cannot complete the final exam during the scheduled time due to a scheduling conflict with an AP Exam or illness, he or she should make arrangements with the teacher to complete the final exam on Friday, May 22.

Advanced Placement Exam Updates

As a result of the school closures due to Covid-19, the College Board has developed secure, online free-response exams for each course. Please take the time to read the College Board AP updates for the most up-to-date information regarding AP testing. Course-specific exam information including exam dates, times and a description of what you'll be asked to do on your exam can be found using this link.

Key points on updates:

- 1. Exams will be given from May 11 through May 22. Take a look at the updated schedule <u>here</u>.
- 2. For most subjects, the exams will be 45 minutes long, and include an additional 5 minutes for uploading. Students will need to access the online testing system 30 minutes early to get set up.

- 3. Like many college-level exams, this year's AP Exams will be open book/open note. Get tips for taking open book/open note exams.
- 4. Click on this <u>link</u> to learn about exam security.

Important tasks for students to complete immediately:

- 1. Log into AP Central to make sure the email address you provided is correctly entered. You will receive a link to the exam on exam day through this account and a video demonstrating how to access the exam in late April. It is <u>CRITICAL</u> that you are able to access your College Board account. You can find instructions on how to do this below. If you are having trouble logging in, follow the <u>steps provided by the College Board</u> to troubleshoot.
- 2. For seniors, if you have committed to a school, list the school you want the College Board to send your scores to. (Found in your AP Profile)

How to verify your email address on the College Board website.

- 1) Log into your AP Student account
- 2) Click on the yellow circle with your name on it in the upper right hand corner
- 3) Click on "Account Settings" (it will ask you to enter your password again)
- 4) Enter your password and click the yellow "verify" button
- 5) Scroll down and enter your email address (in both spots)
- 6) Scroll to the bottom and click update.

Please know that ALL communication for your AP exams on test day will come to you directly from the College Board, and no one at Glenbard South has the ability to grant you access to your account on that day. Make sure you have access in advance so that you do not get locked out of your exam and miss it on test day.

College Board Suite of Assessments: SAT Update

College Board has announced they will NOT be able to administer the SAT® and SAT Subject Tests™ as planned on June 6, 2020.

They are working hard to make the SAT available in school and out of school as soon as the public health situation allows. Students will have opportunities to take the SAT to make up for this spring's lost administrations.

If it's safe from a public health standpoint, College Board will provide weekend SAT administrations every month through the end of the calendar year, beginning in August. This includes a new administration in September and the

previously scheduled tests on August 29, October 3, November 7, and December 5.

Students will be able to register for these administrations beginning in May. College Board will communicate directly with students when the exact date is available. Eligible students will be able to take the exam with a fee waiver. Students who were registered for June and those in the high school class of 2021 who don't have SAT scores will have early access to registration for the August, September, and October administrations.

For each administration, College Board is preparing to significantly expand capacity for students to take the SAT when schools reopen. We're calling on our member schools and colleges, as well as local communities, to open their doors and provide additional test center capacity so every student who wants to can take the SAT.

In the unlikely event that schools don't reopen this fall, the College Board will provide a digital SAT for home use, much as we're delivering digital exams for three million Advanced Placement® students this spring. As they are doing with at-home AP® Exams, we would ensure that at-home SAT testing is simple; secure and fair; accessible to all; and valid for use in college admissions.

College Board is committed to giving students as many chances as they can to show their strengths to admissions officers. As we navigate this evolving situation, we'll continue to rely on your partnership to ensure students have what they need as they apply to college during the 2020-21 school year.

SAT and AP Tests

The College Board, which administers both the SAT and AP tests, is continually updating its website.

SAT — See the "SAT Coronavirus Updates" webpage. The SAT for May 2 has been canceled, as well as the June test.

AP — See the "AP and Coronavirus Updates" webpage for information for AP students as well as AP teachers and coordinators. Note: Traditional face-to-face exams will not take place. Students will take a 45-minute online free-response exam at home. For each AP subject, there will be two different testing dates. Free online review courses are available. Information for higher education professionals on test security and validity is also available.

ACT Tests

ACT has rescheduled its April 4 national test date to June 13 across the US. All students registered for the April 4 test date will receive an email from ACT informing them of the postponement and instructions for free rescheduling to June 13 or a future national test date. Please check the ACT website for updates.

Information about student fees, credits, refunds

Information about student fees, credits, refunds

We continue to deliver remote learning instruction to our students through iPads, digital curriculum and Schoology, our learning management software. Our teachers are coordinating this instruction with students and this will continue until the end of the scheduled school year.

There have been questions from our families regarding student fees. The following information should assist our families regarding Glenbard fees during this time.

School Fees:

Registration & Fees: Students will receive instruction for entire school year; therefore, the fee is valid for this year.

iPad Rental Fee: Students will receive instruction for entire school year; therefore, the fee is valid for this year.

Digital Curriculum Fee: Students will receive instruction for entire school year; therefore, the fee is valid for this year.

Behind the Wheel (Driver Education Fee): We will provide completion of behind the wheel instruction for students in the fall 2020 semester. Fee is valid.

Athletic Fee: The athletic fee of \$150 allows the student to participate in unlimited sports. Because spring sports have been cancelled, we will credit the student's fee statement \$150 if the student has signed up for a spring sport only.

Parking Fee: Due to the pandemic, we missed 44 on-site instruction days out of 176. Therefore, 25% of the paid annual parking fee will be credited to the student's account. If a student parking pass was only for the second half of the year, they will receive a 50% credit of their paid fee.

Summer School Fees (Summer 2020): We have waived fees for summer school 2020, due to the pandemic. If you have already paid this fee, we will credit your account for the amount paid.

Credits/Refunds:

We will provide credits to student accounts per above.

Returning students: We will apply credits to student's accounts toward next year's fees.

Graduating seniors: We will issue a refund check by mid-June for those seniors who have a credit balance on their accounts.

No Action Needed to Receive Credit/Refund

Our business office will automatically process any credits/refunds; families do not need to do anything to receive a credit/refund.
